During this workshop, the presenter will discuss the important of family therapy in treatment of the young adult. The differences between 30 day and 90 day treatment programs and why the longer length of stay is important for young adults will be discussed. The presenter will also discuss the differences between buprenorphine based medications vs. naltrexone based medications.

Experts in addiction treatment generally recognize that young adults have more difficulty achieving sobriety than their adult counterparts. Some of the age-specific challenges have been identified in recent studies which indicate that young adults with addictive disorders are seldom addicted to just one substance or behavior. Additionally, they are experiencing significant life changes and are subject to intense peer pressure. This workshop will explore the many reasons why treatment for young adults (age 18-25) should address these difficulties and be tailored to the therapeutic needs of young adult patients, as they are learning to navigate their constantly changing social environment.

Learning Objectives:

- Participants will be able to describe the difference tetween a 30 day and a 90 day treatment program for young adults.
- Participants will be able to discuss the differences between buprenorphine based medications vs. naltrexone based medications.
- Participants will be able to explain the importance of family therapy in treatment of the young adult.
